This Agreement relates to the application of any current and/or future student(s) of Loyola College linked to the parent(s)/guardian(s) above to board the Doreen-Greensborough North to Loyola College daily morning bus service.

THE PARTIES AGREE AS FOLLOWS:

1. This agreement is ongoing from Semester to Semester and Year to Year.
2. Parent(s)/Guardian(s) will be notified of any change to the scheduled times and stop locations.
3. Should a parent/guardian wish to withdraw a student from using the Doreen-Loyola Bus Service, written notification via email, must be emailed to belln@loyola.vic.edu.au, no later than two (2) weeks prior to the end of the current Semester.
4. Failure to notify of a cancellation within the required period may result in full fees being owed for the following Semester.
5. Additional student(s) commencing at Loyola College subsequent to the signing of this agreement, and linked to the account of the signatory/ies listed below, will automatically be considered bus users and fees will be applied accordingly.
6. Fees are charged annually, and payment is required by the due date of the account issued unless alternate arrangements have been made.
7. Refund/Credit on cancellations will only be applied against the following Semester, and only when the required notification has been provided.
8. No refund/credit will be payable on any cancellation within a Semester for the given Semester.
9. No refund/credit will be issued for missing the bus, absence due to illness or other reasons including choosing not to use the service on certain days.
10. Loyola College reserves the right to make amendments to this Agreement when necessary. Parents/Guardians will be given no less than twenty-one (21) days notice of any amendment(s) prior to the end of a Semester.
11. In accordance with Clause 3 of this agreement, failure by the parent(s)/guardian(s) to withdraw a student from the Doreen – Loyola Bus Service will be viewed by the College as acceptance of the amendment(s).
12. This Agreement must be read in accordance with the College Fees & Charges Policy (available to view and/or print at www.loyola.vic.edu.au/OurCollege/OurPolicies).

The annual cost per student will be **\$720** for students boarding the bus from **Stops 1 to 5** and **\$660** for students boarding from **Stops 6 to 8**.

Please note that there will be no refunds for missing the bus, absence due to illness or other reasons including choosing not to use the service on certain days.

Amounts will be invoiced on the College Fee Account with payment required by the due date of the account issued. Failure to pay within the required time frame may result in the student being withdrawn from the bus service.
